Stay at Coral Azur Beach Resort

The Public Officers' Welfare Council is organising stays at Coral Azur Beach Resort, Mont-Choisy, for public officers and their families on the following dates :-

First Batch

- (ii) **Group B:** Friday 10 to Sunday 12 April 2015 (Two nights' stay).

Second Batch

- (i) **Group A:** Thursday 16 to Sunday 19 April 2015 (Three nights' stay);
- (ii) **Group B:** Friday 17 to Sunday 19 April 2015 (Two nights' stay).
