Stay at Merville Beach

The Public Officers' Welfare Council is organising stays at Merville Beach, Grand-Bay, a three-star plus hotel, for public officers and their families on the following dates :-

- (ii) **Group B: Thursday 09 to Sunday 12 April 2015 (Three nights' stay).**

(a) Pamplemousses (Nr parking SSR Botanical Garden)	1315hrs
(b) Port Louis (Lay by ex General Post Office Caudan)	1245hrs
(c) St Jean, Quatre Bornes (nr St. Jean church)	1230hrs
(d) Réduit, University of Mauritius (nr bus parking)	1215hrs
(e) Curepipe (nr Municipality of Curepipe, opp. St Thérèse church)	1200hrs

Please note that buses will leave their respective collecting points at the exact time indicated for check-in and check-out. **Latecomers will have to make their own transport arrangements.**

4. Interested public officers are requested to fill in the enclosed form (**Annex B**) and submit same to the Council together with the exact amount. Please note that applicants should submit photocopy of a recent payslip and National Identity Card together with Birth Certificates for children under 18 years while effecting payments.

5. Tickets will be sold on a "**first come first served basis**" on **Saturday 14 March 2015 from 0900 hrs to 1430 hrs and on weekdays as from Monday 16 March 2015** at the office of the POWC, 6th floor, ATOM House, 16 Royal Street, P.Louis.

6. Cancellation will be accepted strictly for exceptional cases (e.g. illness, death of close relative supported by evidence).
