The Public Officers' Welfare Council (POWC) is organising a 2- Nights stay at Tamassa, a four-star resort situated at Bel Ombre, for public officers and their families from:

- > Friday 08th December to Sunday 10th December 2023 (20 Rooms available)
- > Sunday 10th December to Tuesday 12th December 2023 (20 Rooms available)

#### 2. The cost of the special all-inclusive package is as follows:

- (iii) Single-parent with child parent pays single rate & child pays additional extra bed/ with teen parent & teen pay half double rate
- (iv) Maximum room occupancy: Tamassa Standard Room 2 Adults + 1 teen or 1 child or 1 baby
- (v) Separate room policy:
  - 2<sup>nd</sup> room for children/teens
  - 1 child/teen = adult single room rate
  - 2 children/teens = adult double room rate
  - 3 children/teens = adult double room rate + additional extra beds (if applicable)

#### 3. The special all-inclusive package comprises the following:

- Check-in at 14 00 hours

- 4. Participants will have to make their own transport arrangements.
- 5. Interested public officers are requested to fill in the enclosed participation form at Annex 1 and submit same to the Council together with the exact amount on scheduled payment date. The following documents should be submitted while effecting payments:
  - (i) Photocopy of a recent payslip/top part of the payslip indicating the name, paysite code and National Identity Card number or any written evidence/document attesting that the applicant is a serving public officer;
  - (ii) Photocopy of National Identity Card for each adults.
- (iii) Photocopy of Birth Certificates for participants aged below 18 years.
- 6. Payment will be received on a <u>"first come first served basis" as from 09 30 to 14 00 hours</u> at the seat of the POWC, Level 12, SICOM Building II, Corner Chevreau & Reverend Jean LeBrun Streets, Port-Louis.

Participants are kindly requested to effect payment, preferably by cash, card or cheque to the order of "Public Officers' Welfare Council".

- 7. Cancellation will be accepted in exceptional cases (e.g. illness, death of close relative or any other valid reason) supported by documentary evidence. In case of cancellation, an administrative fee of MUR 200 per participant together with other cancellation charges claimed by stakeholders will be applicable.
- **8.** The Council reserves the right to cancel the stays in case of unforeseen circumstances. Participants will be refunded accordingly.
