FUTSAL FESTIVAL 2020

In the context of the 52nd Independence Day Celebration of the Republic of Mauritius, the Public Officers' Welfare Council (POWC) is proposing to organise a Futsal Festival for **male Public Officers** as from **end of March 2020**.

2. Two separate Futsal Festivals will be organised as follows:
 - Civil Service Futsal Festival; and
 - Disciplined Forces Futsal Festival
3. The Tournaments will be played on a **Knock-Out System**.
4. The exact date and venue for the holding of the Festival will be communicated to participating teams in due course. Participating teams should make their own arrangement for transport as well as release of players/officials from their respective Ministry/Department for training purposes and official matches.
5. Each participating team, after having played all its matches, will be entitled to a grant of Rs. 1000 which will be credited in the bank account of its Staff Welfare Association.
6. Ministries/Departments interested to participate in the above Festival are requested to fill in the Participation Form at Annex A and submit same to the Organising Secretary, Public Officers' Welfare Council, 6th Floor, ATOM House, 16, Royal Street, Port Louis by **Wednesday 11 March 2020** at latest. **It is compulsory that the Participation Form should contain the seal of the participating Ministry/ Department and be duly certified by its Supervising Officer as well as its Human Resource Section.**
7. Team Managers are invited to attend a meeting as well as the drawing of lots scheduled for **Monday 16 March 2020 at 1400 hours in the Conference Room of the POWC, 6th Floor, ATOM House, Port Louis. The Rules and Regulations of the Festival will be communicated to Team Managers the same day.**
